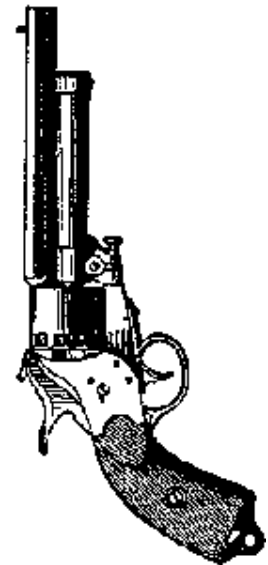
FROM THE LSFSC PRES CONTINUED
